- Accountable for technical transfer activities into, within and out of the site.
- Support excellence in manufacturing through standard setting and technical capability development and deployment.

- Previous solid experience in a similar role within the pharmaceutical/biotech industry.
- Proven people management skills.
- Extensive knowledge of GMP processes, analytical methods validation and tech transfer.
- Fluent in English.
- Demonstrate an agile mindset by setting clear priorities, collaborating openly, and using feedback to make step-by-step improvements – reflecting the core elements of Agile culture within the Dutch organization.
